### Fundamentals of the Medicare and Medicaid Programs

Each year, approximately 25% of the federal government's budget is dedicated to federal health care programs. In 2020, Medicare spending accounted for 20% of all healthcare expenditures in the nation and Medicaid accounted for 16%. Because Medicare and Medicaid control so much of the healthcare market, it is important for healthcare attorneys to understand these programs. This presentation discusses the fundamentals of these two programs, including their structures, reimbursement methods, and managed care. The presentation is geared toward attorneys new to federal healthcare programs or seasoned attorneys looking for a refresher.

# **Prosecuting and Defending False Claims Act Cases: Points of Contention and Collaboration**

The False Claims Act, 31 U.S.C. §§ 3729-3733, has been used by qui tam relators and the Department of Justice as the primary vehicle to protect and recover federal funds paid due to fraud and abuse. From the perspectives of both plaintiff and defendant, this presentation will discuss the impact and implications of qui tam actions, common areas of dispute, opportunities for collaboration, and practical considerations for prosecuting, defending, and resolving such cases.

**Paul Giancola.** Paul Giancola is Of Counsel with Snell & Wilmer, LLP and an Adjunct Faculty at the Sandra Day O'Conner College of Law where he teaches Health Care Fraud Law. Paul's health care practice is focused on providing regulatory counsel on fraud and abuse laws, compliance, government investigations and audits, contractual matters, HIPAA privacy and cybersecurity, and transactional health care matters including joint ventures, practice/entity formation, acquisition and separations, ambulatory surgery centers and laboratories.
