# The Opioid Epidemic: How the Nation Set Up then Failed to Stop One of its Worst Public Health Emergencies

For over 2 decades, an opioid epidemic has plagued the U.S., killing more than 600,000 Americans who were taking prescription and illicit drugs. Since 2017, opioid misuse has been the basis for a national public health emergency declaration and multiple state emergencies. In the shadow of the COVID-19 pandemic, the opioid epidemic has charged forward. Over 100,000 Americans died from the use or abuse of drugs (the great majority of which were opioids) in 2021 alone. Join our panelists for a discussion on (1) how the opioid epidemic has impacted the U.S.; (2) how political influences have handcuffed the DEA's ability to curb the epidemic's effects during multiple Presidential administrations; and (3) the epidemic's uncertain legal landscape, with thousands of lawsuits based on novel legal theories, and many large settlements involving Big Pharma, drug distributors, and others, of varied success.

Since the U.S. Supreme Court overruled Roe v. Wade in July and returned abortion regulation to the states, Arizona has struggled to reconcile the 15-week limitation passed last year with the nearly complete abortion ban that has survived in Arizona law since Territorial days. With this in mind, our session will look at the status of abortion in Arizona. Included will be a report on pending litigation, a survey of the difficult abortion service questions posed by the laws in place, and a discussion of the varying strategies providers are using to try to continue to lawfully provide services and keep providers safe from potential criminal penalties.
